LANDSCAPE IN THE LONGUE DURÉE

A HISTORY AND THEORY OF PEBBLES IN A PEBBLED HEATHLAND LANDSCAPE

UCL Press Pebbles are usually found only on the beach, in the liminal space between land and sea. But what happens when pebbles extend inland and create a ridge brushing against the sky? Landscape in the Longue Durée is a 4,000 year history of pebbles. It is based on the results of a four-year archaeological research project of the east Devon Pebblebed heathlands, a fascinating and geologically unique landscape in the UK whose bedrock is composed entirely of water-rounded pebbles. Christopher Tilley uses this landscape to argue that pebbles are like no other kind of stone - they occupy an especial place both in the prehistoric past and in our contemporary culture. It is for this reason that we must re-think continuity and change in a radically new way by considering embodied relations between people and things over the long term. Dividing the book into two parts, Tilley first explores the prehistoric landscape from the Mesolithic to the end of the Iron Age, and follows with an analysis of the same landscape from the eighteenth into the twenty-first century. The major findings of the four-year study are revealed through this chronological journey: from archaeological discoveries, such as the excavation of three early Bronze Age cairns, to the documentation of all 829 surviving pebble structures, and beyond, to the impact of the landscape on local economies and its importance today as a military training camp. The results of the study will inform many disciplines including archaeology, cultural and art history, anthropology, conservation, and landscape studies.

WORK-RELATED LEARNING

Springer Science & Business Media Work-related learning (WRL) is a topic of steadily increasing interest to today's vocational education institutions as well as organizations in business and industry. This book derives from an international HRD conference held at the University of Twente, The Netherlands. Key papers from the conference have been combined with other high-standard contributions. Formal and informal learning are distinguished from each other with respect to the level of intention (implicit/non-intentional/incidental versus deliberative/intentional/structured). Another point of discussion originates from the different 'theoretical backgrounds' of the authors: the 'learning theorists' versus the 'organizational theorists'. The first group is mainly interested in the question of how learning comes about; the second group is predominantly interested in the search for factors affecting learning. This book is essential reading for practitioners, researchers, teachers and students in the HRM and HRD field as well as in the field of VET.

RESIDENTIAL END USES OF WATER

American Water Works Association The American Water Works Association Research Foundation (AWWARF) and 22 municipalities, water utilities, water purveyors, water districts and water providers funded this study. Goals of this research included: Providing specific data on the end uses of water in residential settings across the continent; Assembling data on disaggregated indoor and outdoor uses; Identifying variations in water used for each fixture or appliance according to a variety of factors; and Developing predictive models forecast residential water demand. This report represents a time and place snapshot of how water is used in single-family homes in twelve North American locations. Similarities and differences among 'end users' were tabulated for each location, analyzed and summarized. Great care was taken to create a statistically significant representative sample of customer for each of the twelve locations. However, these twelve locations are not statistically representative of all North American locations.
